EXPLANATION OF FEES:

- **INSTITUTE REGISTRATION FEES** cover all materials required for Institute sessions, faculty leadership, opening reception, and closing dinner.
- **Residence hall room and board** includes a single occupancy room (with shared bath), linen service, and a la carte meal plan (\$176.50). Your meal plan may not cover all your dining costs; please budget accordingly.
- **OPTIONAL Graduate tuition for course HE 6541, Developmental Education Applications**, covers faculty support for the development of a practicum project to be implemented on the participant's home campus in the academic year following the summer residency. Those desiring certification as a Developmental Education Specialist through the Kellogg Institute should elect this course.
- **OPTIONAL Graduate tuition for course HE 6090, Seminar in Adult and Developmental Education**, can be elected in addition to or instead of HE 6541. Participants enrolling in HE 6090 will be required to prepare reflection papers to be graded for credit.

NOTE: Instructions for applying to Appalachian State University as a non-degree student will be sent to those electing a graduate credit option. You should include the \$55 Cratis D. Williams Graduate School application fee in *budgeting* for your cost of attendance. **PLEASE do not include this fee in your payment to Kellogg. The \$55 fee is payable to the Appalachian State University Graduate School** when completing that application.

CANCELLATION POLICY: Deposits are non-refundable. In the event you must cancel your registration, you have the option to transfer your application and deposit to the following summer's Kellogg Institute. Institutions may request sending alternate participants in cases where the original applicant must cancel. Cancellation requests should be made in writing; Email to kellogg@appstate.edu. Cancellations received after July 1 will be charged 25% of the Institute fee. Applicants who purchase the resource package but cancel prior to registration will not receive the package, and the price, if paid, will be refunded.
